3	SECTION 1. CABINET MEMBER RESIDENTIAL SECURITY AL-

5	(a) In General.—Chapter 59 of title 5, United
6	States Code, is amended by inserting after section 5949
7	the following new section:

2	"(a) In General.—The Director of the United
3	States Secret Service Uniformed Division shall reimburse
4	each eligible Cabinet member for—
5	"(1) any costs incurred by such eligible Cabinet
6	member for the acquisition or installation of safety
7	and security equipment, including cameras, motion
8	sensors, video recorders, door locks, and lighting, at
9	any personal residence of such eligible Cabinet mem-

11	"(2) any recurring monthly fixed costs incurred

13	"(A) maintaining safety and security
14	equipment at any personal residence of such eli-
